SHOW GUIDELINES

- We do not guarantee the same space as the previous year's show. All spaces will be assigned by Little Log House.
- Vendors are required to be open during the show hours (8 am – 5 pm) all 3 days. Vendors who do not abide by this, may not be welcome back to the show.
- No driving inside the grounds to load or unload between 8 a.m. – 5 p.m. & no parking inside grounds unless the vehicle is within your paid vendor space
- Please limit the use of garbage receptacles for waste accumulated from the event. Take your own unwanted items/cardboard etc. with you. *Vendors who leave waste, products or tents behind will be charged accordingly!*
- Food & Beverage Sales are absolutely not allowed (e.g., prepared foods, bottled water, canned soda, etc.)
- We do not give refunds for any reason

The following terms and conditions define the agreement between you as the Vendor and Little Log House. Participating in the Flea Market is contingent on agreeing to, as well as adhering to, these terms. Failure to follow the Terms and Conditions of this agreement will result in you being immediately escorted off the Little Log House Property and/or exclusion from participating in future shows. All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety shall be strictly adhered to.

Conduct

- No form of harassment, bullying, malicious or abusive language or conduct will be tolerated towards visitors, vendors, exhibitors, security personnel and Little Log House staff or volunteers.
- You will comply with the Terms and Conditions listed herein to participate in the event during setup and teardown.
- We reserve the right to refuse entry to our event, refuse service or ask you to leave the property at any time and for any reason.
- The consumption or sale of alcohol, cigarettes/vapes, legal or illegal drugs on the property is strictly prohibited. Law enforcement will be contacted if this is an issue.

Prohibited Items

- Alcohol and drugs
- Flea Market Vendors may sell pre-packaged food items that are for consumption at home or a later date and are required to follow safe food handling guideline procedures and product labeling as described in the Minnesota Department of Health regulations.

Vehicle Operation/Parking

- Outdoor Vendors may park their vehicle within their reserved site, however during show hours it needs to remain parked. Vendors are to use the General Admission Parking Lot for access to your vehicle during show operation hours. Should you need a ride to your vendor space, you can go to the Registration Building for assistance.

Trash & Recycling

- Please leave your site how you found it. Please take all trash, cardboard, and any items you don't sell with you. Vendor's who leave excessive or unnecessary trash behind will be billed accordingly and may not be invited back to the show. Please breakdown cardboard and place it near the trash cans for our staff to collect and dispose of in the proper recycling receptacles.

Insurance

- You are responsible for having and providing your own insurance. Little Log House is not responsible for and does not cover any damages to vendors vehicles, tents, tables/chairs, products, inventory, campers, trailers or any other personal property. We are not responsible for any lost or stolen items.

Pets

- I understand that I am responsible for any pet(s) I bring to Little Log House Pioneer Village. Little Log House Properties is not liable for your pet if it is injured or injures something or someone. I understand that my pet will be leashed at all times & that I am responsible for the clean-up of my pet. Pets that bark a lot and are not used to being around children are not a good fit for the event.

It is understood and I agree that by signing this agreement I fully release and hold harmless the Little Log House Antique Power Show from any and all liability for all claims of every nature, including death, personal injury, loss, theft, damages to personal property.
